

# Point72 Ventures and Spark Capital Co-Lead Stoke Space's \$1 Billion Series E

Gunderson Dettmer represented Point72 Ventures and Spark Capital as co-lead investors in the \$1 billion Series E financing of Stoke Space. General Innovation, Glade Brook Capital, US Innovation Technology, Washington Harbour Partners, Woven Capital, Y Combinator, and other new and existing investors also participated in the round.

Stoke is building fully and rapidly reusable launch vehicles designed to provide reliable, on-demand transportation to, through, and from space. The new funding brings Stoke's total capital raised to \$2.3 billion and will support the company as it prepares for its first orbital launch, expands production and launch capacity, and accelerates development of its larger Nova Block 2 launch vehicle.

"Stoke is pursuing what we see as one of the most important opportunities in space transportation: making launch fully reusable, reliable, and scalable," said Chris Morales, Partner at Point72 Ventures, [in the announcement of the transaction](#).

"Having supported Stoke through multiple stages of its growth, we believe this company has demonstrated both the exceptional technical progress and the ambition to build a launch system capable of serving the market at industrial scale."
